Entry Fee: **(\$100.00 per team) Participants can pay at the Launch Site, prior to blast off.**

Payback: **50% Pay back to field (1st 2nd 3rd 4th team places Guaranteed) will pay top five teams with 50 plus boats. 1 and 10 thereafter up to 10th place.**

50% will be given to Colors for a Cause to help support area children fighting cancer

RULES

- 1) All contestants may launch from Big Bass Marina; Trailing will be allowed and first line in water at 6 A.M**
- 2) All live wells will be checked prior to launching.**
- 3) Best five (5) fish per team at weigh in. All fish must be 14 inches minimum (including spotted bass). 1/4-pound deduction for each dead fish weighed.**
- 4) No live bait will be used during tournament. Only artificial baits and pork rinds allowed.**
- 5) No trolling with use of main boat motor will be allowed.**
- 6) All participants must register (check-in) no later than 5:45 A.M. the day of the tournament. An identification ribbon will be given at the time of the live well check and must be prominently displayed on each boat (i.e. tied to trolling motor, running light, wind shield, etc.).**
- 7) All participants must sign the entry form and have it turned in to tournament officials before blast off.**
- 8) Personal checks will not be accepted. All entries must be received by 5:45 a.m. the day of the tournament (again, no checks will be accepted at the launch site). All participants may be subject to a polygraph test.**
- 9) Participants not present at the 3:00 p.m. ROLL CALL will be disqualified.**
- 10) Anyone caught violating these rules will be subject to disqualification. All decisions made by the tournament committee will be final.**
